GO GREEN! Receive your invoice by email

The Town sends out approximately 450 utility notices each month and we currently have approximately 60 customers signed up to receive their invoice by email.

Receiving your invoice by email will ensure you receive your invoice in a timely fashion. Currently, our local mail has to travel to Saskatoon before it is sorted and delivered to your post office box.

Sending our invoices by email saves the town time, paper, envelopes and postage.



PTIC-SCF Grant — Town of Birch Hills

Provincial Territorial Infrastructure Component—Small Communities Fund

The Provincial Territorial Infrastructure Component (PTIC) is part of the New Building Canada Fund (NBCF). PTIC is divided into two sub-components: 1. National and Regional Projects (PTIC-NRP) 2. Small Communities Fund (PTIC-SCF).

The Town of Birch Hills made application for funding to the PTIC in January 2017 for Water Treatment Plant Upgrades. Finally on September 11, 2018, the governments of Canada and Saskatchewan announced more than \$80.9 million in combined federal, provincial and local community funding under the Small Communities Fund Component. Deputy Mayor Sharon Rolfes had the honour to attend the press conference as Master of Ceremonies where she had the opportunity to introduce Honourable Francois-Philippe Champagne, Minister of Infrastructure and Communities, and Honourable Warren Kaeding, Minister of Government Relations. Deputy Mayor Sharon Rolfes also had the opportunity to speak about Birch Hills and our project plans. On September 11, 2018 it was confirmed that the Town of Birch Hills will receive \$3.7 million dollars in combined federal, provincial and local grant funding.

The Town of Birch Hills will be signing the federal, provincial, local grant contribution agreement in the very near future. Any project costs incurred prior to signing the contribution agreement are not eligible for funding. We are extremely exited to start this project as our water system needs upgrades in order to meet the new Regulations and Standards coming into effect in 2020.

The Town of Birch Hills is grateful to receive continued support and funding from the federal and provincial government to assist in our rapidly aging infrastructure within our community.

Pet License & Business License

Your 2018 Pet License and 2018 Business License is going to expire December 31, 2018. Renewals are now available at the Town Office for 2019! Licenses are required annually for both pets and businesses. The license year runs from January to December and required to be renewed each year.

Please remember if you have a dog or cat, they need to be registered at the Town Office — Or if you own a business outside of a commercial premises, you need to obtain a municipal business license from the Town Office.

Water & Sewer Utility Bill Payments

Thank you to all the residents who have taken a special interest in keeping their property neat and tidy.....it has not gone unnoticed.

The Town has completed some enforcement with troubled properties and is still in the process of enforcement with some others.

However, there are still many properties that contravene the requirements of our municipal bylaws and due to numerous complaints and comments, we will be continuing to strongly enforce these bylaws with notices of violation.

Building Permits

Please remember that a building permit is required whenever work regulated by *The Uniform Building and Accessibility Standards Act* and *Regulations* and the National Building Code of Canada.

Changes to the Building Code of Canada will come into effect in January 2019.

Building permit applications and forms can be obtained at the Town Office or on the town website at www.birchhills.ca, under forms & permits. All building permits have to adhere to the Town's Zoning Bylaw and Building Bylaw.

Construction is prohibited to start until the applicant receives all required approval from Town Council and the Municipal Building Official.

Applications needs to be reviewed and approved at a Regular Meeting of Council then sent to our municipal Building Official for the required plan review before any approvals are granted to the applicant. The Town will forward all applicable approvals, with the building permit fee invoice to the applicant as soon as they are received in the office.

Once the plan review and responsibilities are reviewed and the building permit fees are paid by the applicant, construction can commence.





First Fire Truck in Birch Hills—1923 Model "T":

Birch Hills Volunteer Fire & Rescue Department

How we began......This 1923 Model "T" was the first unit purchased by Birch Hills in the creation of the Fire Department in 1924. The bed of the truck contained two steel cylinders filled with soda, and in each of these cylinders were a single glass container filled with Acid. The activation process began at the rear of the unit where you would find a manually activated hand crank and by rotating this firmly 90 degrees it would break the glass inside the cylinders and the resulting chemical interaction would provide a Foam Agent to smother early stage fires.

To assist in the abilities of this unit to perform fire suppression duties, the "T" pulled a twowheeled cart that held an additional water tank. This water was made available by two firefighters each grabbing one end of the pump handles and manually supplying the power to pump water. The output of this process was totally dependent on the strength and speed of the members manning the handles.

This unit was the only fire truck from 1923 to 1949. In 1949 the "fleet" was increased by the purchase of a used 1946 Ford Truck and the Birch Hills Volunteer Fire Department was born. The 1946 Ford was a major improvement; it was powered by a V8 with a PTO. The members at that time converted this unit by the addition of a water tank and PTO driven pump to increase the abilities of this unit and fill the "T" and pump tanks.

In 1966 changes were at hand again with the purchase of a used 1952 Chevrolet Fire Truck from the Prince Albert Fire Department. The department expanded their coverage area in 1967 with the addition of fire coverage for the RM of Birch Hills.

Sadly, 1950 was the last year of "Active Service" for the Model "T" as she was decommissioned from active duty. But, on the plus side — We Still Have Her! Her primary use now is for parades only and she appears in these under her own power. With a little TLC she would probably pump water again!

Currently, the Birch Hills Volunteer Fire and Rescue Department is owned by both the Town of Birch Hills and the R.M. of Birch Hills No. 460 with administration through the Town Office. To date our "fleet" consists of: Pumper Unit—1990 Grumman Pumper Truck that was purchased if 2009; Snuffer Unit—1996 Freightliner FL80 Tandem that was purchased in 1996; Tanker Unit—1973 Mack Truck that was purchased in 2004; and Command Unit—1999 Ford F450 Diesel 4x4 that was purchased in 2015.

Water & Sewer Utility Billing

Important things to remember

- Utility bills are generated on the first of each month. This bill is for water usage for the previous month.
- Water meters are read monthly. Therefore, all monthly bills are based on actual consumption.
- Penalty of 10% will be added to all outstanding water and sewer accounts at the date of next billing.
- If a Utility account remains outstanding more than 60 days, the Town will disconnect services.
- Upon disconnection for non-payment, the utility service will be reconnected only after all arrears and reconnection fees are paid in full.
- If any accounts remain unpaid for 120 days, the outstanding amount may be added to and thereby form part of the taxes on the land or buildings with respect to which service was provided.

HOW TO READ YOUR WATER METER



The Water Utility will read your water meter for billing purposes, but should you wish to monitor your own consumption, here's how:

- Shine a flashlight over the flashlight icon (located on the register) to activate the LCD display *
- Take a reading at a set time of the day
- Take a 2nd reading at the same time the next day
- The difference between the two readings is your daily water consumption

* Note: when the register display is first activated via a flashlight, all icons will be briefly displayed followed by firmware information. The register display will then toggle (every 4 seconds) displaying the reading and then the flow rate. The flow rate is per minute. When the display indicates "RATE", the flow rate is being displayed.

Leak Indicator Displays a possible leak

OFF - indicates no leaks

- Flashing water usage for more
- than 50% of time in 24 hour period Continuous ON – there is most likely a leak in your home
- The LCD figure displays your meter reading in cubic metres. The last 4 digits are decimal points. (e.g. – 26.3987 cubic metres) (decimal will be displayed)

RATE

- ON- water in use
- OFF water not in use

Flow Indicator

Displays direction of water flow

- Flashing water is running slowly
- (-) indicates reverse flow
 (-) indicates forward flow
- (+) indicates forward flow

Unusual higher consumption (bills)? Check for leaks.....most leaks are unnoticeable. Take a night water meter reading when you are done using water for the day, followed by a morning reading. Meter movement overnight may mean a plumbing issue. Also, check the Leak Indicator on your water meter. Please call your plumber to fix any problems.

One of the most common issues is a leaking toilet. A good test to use is the dye test. Put a few drops of food coloring in the tank of your toilet. Do not flush your toilet for at *least* 30 minutes. Food coloring should not appear in your toilet bowl. If the food coloring does appear, then your toilet is leaking and you should contact a plumber to fix the problem.

Plumbing leaks add up fast!

Drip—1 drip per second wastes 32.7 litres daily and 11,937.6 litres yearly Dribble—3 drips per second wastes 98.1 litres daily and 35,813.2 litres yearly Drool—5 drips per second wastes 163.5 litres daily and 59,688.6 litres yearly Leaking Toilets—a running toilet could be wasting more than 750 litres in a day Leaking Showerhead—a showerhead that drops 10 drips per minute wastes more than 1,800 litres per year
